

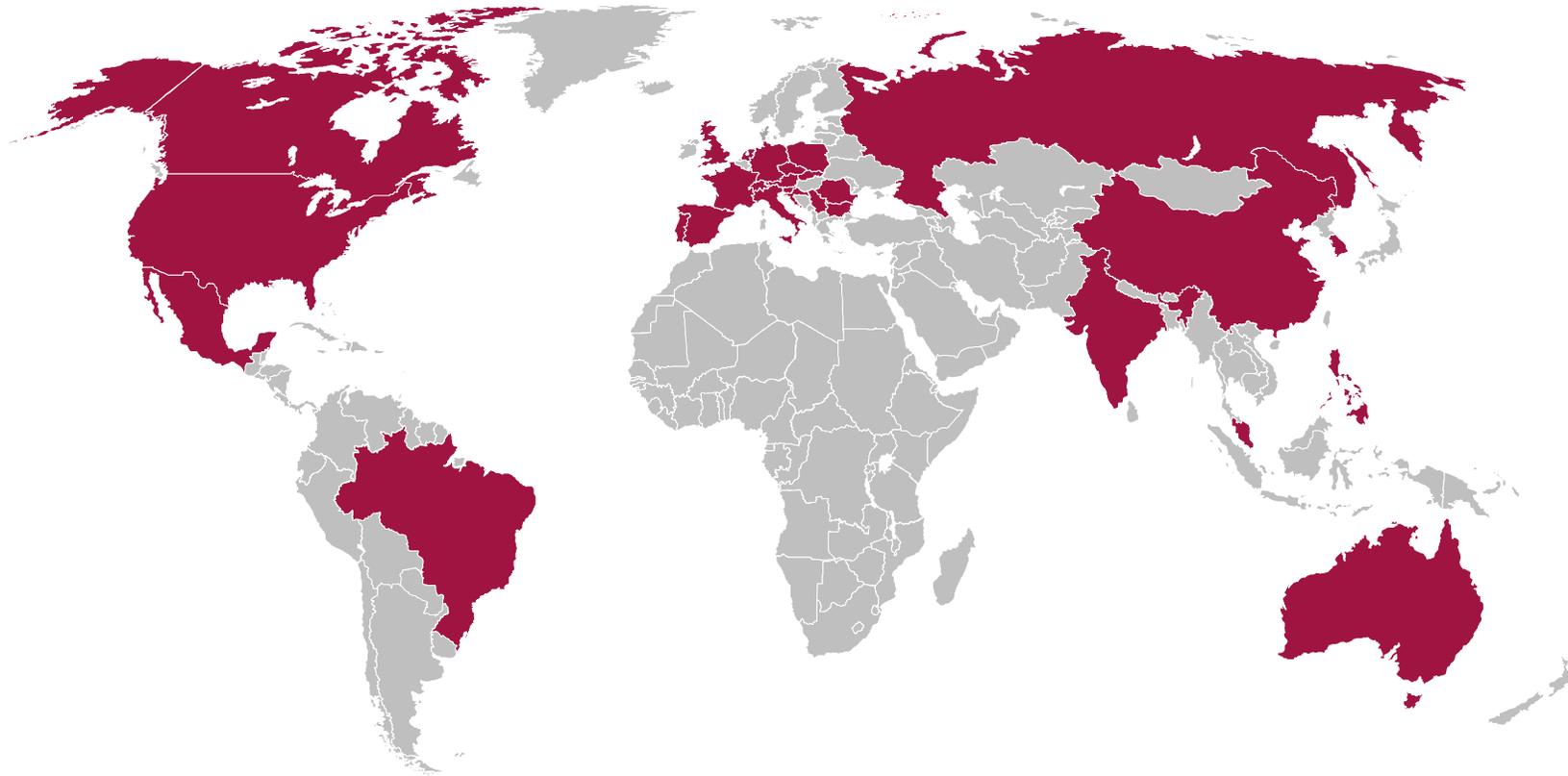

E-invoicing Romania general overview

E-invoicing and RO E-Factura system were created to respond the need for digitalization and standardization in this area of invoice exchange B2G and B2B

Framework

High fiscal risk products first for B2B invoicing

These products were determined by ANAF in their published draft list. High fiscal products include,

Vegetables, fruits, roots, edible tubers, other edible plants

- Alcoholic beverages
- Mineral products
- New construction
- Clothing and footwear

This ANAF list will be gradually extended.

Reporting frequency

Monthly

Grace period in place April – June 2022

Format

XML file

E-invoicing effective from

01.07.2022 for all the high-risk fraud product categories

2023 – the rest of the products and services, gradually

Specifications

The national specs for usage of e-invoice - RO_CIUS –are the technical specs for using the basic elements of the e-invoice such as they are described into the European Standard SR EN 16931-1, applicable in Romania;

Submission

Submission of the e-invoices will be done only through the e-invoicing system

Enrollment via SVP

Digital signature is needed

The main elements of the e-invoice are:

- process and invoice identifiers
- invoice date
- identification info regarding the company issuing the invoice to deliver goods/ products or delivered services, executed the works;
- identification of the type of goods/ products, services or works delivered
- reference to contract for public/ sectorial acquisition lease of works and services or also, if the case, to the public acquisition contract for defense and security areas ;
- information regarding the addresses of the e-invoice;
- information regarding the payment beneficiary;
- information regarding the fiscal representative of the issuer;
- details regarding the works execution, delivery of goods/products, or services;
- payment instructions;
- information regarding accounts payable/ accounts receivable;
- information regarding invoice different positions
- VAT detailing
- invoice total.

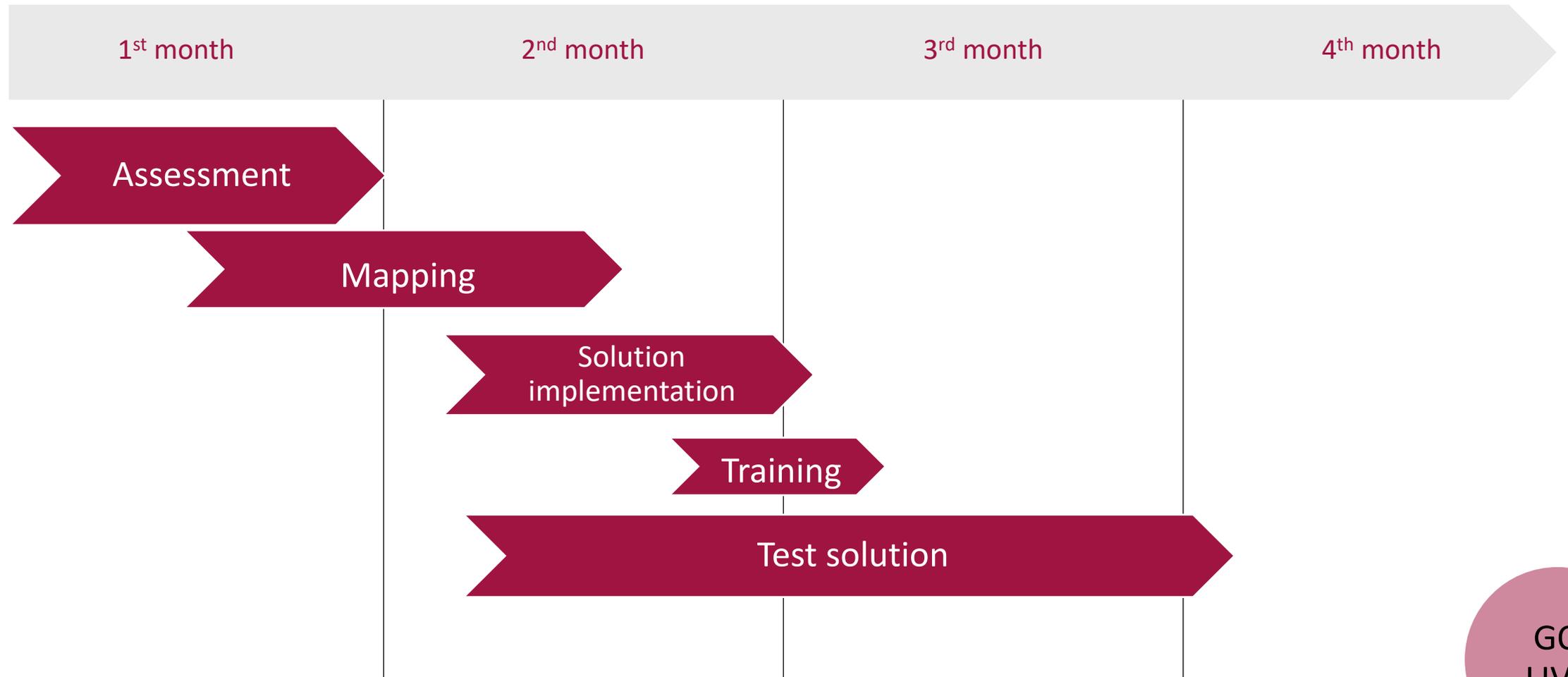
